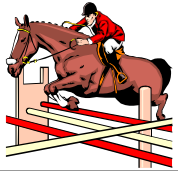

B. RIDING FEES

ALL RALLIES ARE PAY AS YOU RIDE

\$20.00 per lesson – instruction fee.

Up to 4 riders per lesson \$20.00 (every endeavour will be made to have no more than four riders per lesson). Please check with your rally coordinator (or in the newsletter) as rally fees may vary with specialist and/or guest instructors.

C. GUESTS (Please note that this policy is under review- when finalized all members will be notified)

\$30.00 per lesson for a maximum of three lessons

The guest rider must be a current financial member of the HRC AV and be insured and be able to produce their

membership card as proof of their insurance. If numbers permit, guests will be allowed to ride at a cost of **\$30.00** per lesson for three lessons before deciding to join. ALL guests must sign a disclaimer before riding; must wear an asa approved riding helmet and properly heeled shoes

Please note we will not accept any membership application or renewal form without a signed HRCav Annual Disclaimer Statement.

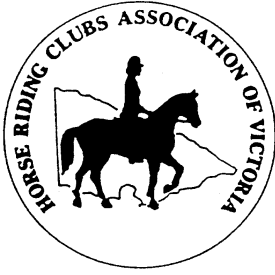
D. CHAFF CHAT* (Worth having if you are going to compete) *Optional

The annual Chaff Chat (the monthly newsletter from the HRCav) subscription is **\$42.00***. The Chaff Chat year is from November to October (inclusive). From January the HRCav offer a pro rata subscription of **\$3.50 per copy** for the remaining months of the subscription year.
